The organisers of VERITAS have announced that the dates for the wine show will this year follow the normal pattern as in the past. See details below.

The VERITAS online entry system makes participation more efficient.

The launch of the *VinoVeritas by CTP* App in 2020 to enable the public to buy Veritas award winning wines directly and have them delivered to their doorstep with Getwine, has been met with great enthusiasm from consumers and participants. The use of the App will again be promoted widely this year.

GESKIEDENIS

Produsente plaas hul vertroue in die beoordelingsproses van die oudste en mees prominente wynkompetisie in Suid-Afrika wat in 1991 begin het en Suid-Afrika se langlopende en mees gesogte wynkompetisie is en erken word as die mees betroubare kompetisie vir markklaar wyne en brandewyne..

BEOORDELAARS

Die jaarlike insluiting van internasionaal gerespekteerde en ervare proeërs dra by tot die gunstige reputasie van hierdie wynkompetisie. Om wyne by die Veritas-kompetisie te proe, is 'n erkende beoordelingsakkreditasie noodsaaklik. Indien moontlik, sal buitelandse beoordelaars weer genooi word. Daarbenewens moet oorsese beoordelaars internationale ervaring hê. Die plaaslike span beoordelaars bestaan uit 'n verskeidenheid wynmakers, navorsers, akademici, Kaapse Wynmeesters, wynkopers, sommeliers, wynskrywers en konsultante.

Veritas streef daarna om die gehalte en professionele uitvoering van die beoordelaars te verbeter om verdere groei vir hierdie betroubare kompetisie voort te sit. Terwyl die insluiting van jonger proeërs, sommeliers en spesialiste met kommersiële agtergrond op die proepanele aandag sal geniet, sal die kundigheid en ervaring van senior beoordelaars voortdurend aangewend word.

BEOORDELINGSTELSEL

Drie in plaas van vyf beoordelaars dien nou op elke paneel, terwyl die 100-punt proe skaal gebruik word in evaluering, in ooreenstemming met internationale standarde. Die beskikbaarheid van slegs 50 kartonne (6x750 ml) van elke wenwyn is nou nodig in plaas van 200 kartonne in die verlede om kleiner produsente te akkommodeer. Deur die bespreking op die panele uit te skakel, is die resultate 'n ware weerspieëeling van die beoordelaars se menings. Veritas streef daarna om die kompetisie te verbeter om die beste moontlike standarde te handhaaf.

BEMARKINGSGELEENTHEDE

Verbruikers neem toenemend kennis van die uitslae en gebruik die Veritas-toekennings as 'n maatstaf om wyne vir hul genot te kies. 'n Dubbelgoud-, Goud-, Uitstaande Silwer, Silwer- en Brons Veritas-plakker op 'n bottel is inderdaad 'n goeie motiverer om die land se beste wyne te koop. Die VinoVeritas by CTP applikasie wat in 2020 bekendgestel is, sal vanjaar verder uitgebrei word om die gesogte Veritas wyne te verkoop. Die wynproeë van die Dubbelgoud en Goue wenners word sedert verlede jaar weer landwyd in al die groot stede gehou.

HISTORY

Producers put their faith in the judging process of the oldest and most prominent wine contest in South Africa that started in 1991 and is South Africa's longest running and most prestigious wine competition and earned the recognition as the most trusted competition for market-ready wines and brandies.

JUDGES

The annual inclusion of internationally respected and experienced tasters contributes to the favourable reputation of this wine competition. International judges will be invited again, if it is possible. To taste wines at the Veritas competition, a recognised judging accreditation is essential. In addition, overseas judges must have international experience. The local team of judges consists of a variety of winemakers, researchers, academics, Cape Wine Masters, wine buyers, sommeliers, wine writers and consultants.

Veritas strives to enhance the quality and professional execution of the judging to continue further growth for this reputable competition. While the inclusion of younger tasters, sommeliers and specialists with commercial background on the tasting panels will continue to receive attention, the expertise and experience of senior judges will be continuously harnessed.

JUDGING SYSTEM

Three instead of five judges now serve on each panel, while the 100 point tasting scale is used in evaluation, in line with international standards. The availability of only 50 cases (6x750 ml) of each winning wine is now required instead of 200 cases in the past, to accommodate smaller producers. By excluding any discussion on the panels, the results are a true reflection of the judges' views. Veritas continues to strive to improve the competition to maintain the best possible standards.

MARKETING EVENTS

Consumers increasingly take note of the results and use the Veritas Awards as a yardstick when selecting wines for their enjoyment. A Double Gold, Gold, Outstanding Silver, Silver and Bronze Veritas sticker on a bottle is indeed a great motivator to buy the country's best wines. The VinoVeritas by CTP App that was launched in 2020 will be extended this year to sell the sought after Veritas wines. The wine tastings of Double Gold and Gold winners will, like last year, be presented country wide in all the major cities.

Museumklasse: 6 x 750ml óf 4,5 liter in die geval van ander verpakkingsgrootes

Brandewyn - 12 x 750 ml óf 9 liter in die geval van ander verpakkingsgrootes

Produkte met 'n kelderprys R500 en hoër beloop kan 12 bottels wyn en 6 bottels brandewyn voorsien.

NB: Hierdie wyn/brandewyn moet op 17 en 18 Oktober 2023 by die Veritas kantoor aangelever word. Veritas sal die wyne by die verskillende proeflokale besorg.

D REËLS EN REGULASIES - WYN

1 Dieselfde wyn (versnit) mag net onder een etiket ingeskryf word. Waar verskillende versniette van 'n wyn wat onder 'n etiket met dieselfde visuele voorkoms en detail verkoop word, mag ook slegs een inskrywing onder sodanige etiket gedoen word.

the awards ceremony takes place. Double Gold and Gold winning wines must be available for sale to Getwine at least until 31 December 2023 for VinoVeritas App clients.

In the case of the Museum classes (classes 96 to 103) a minimum of **45 litres** is needed for entry.

Wine/Brandy that have received Veritas awards in the past, may be entered again.

The minimum quantity required for entry – 225 liter – is also applicable to the under-mentioned classes:

Straw wine (class 39); Noble Late Harvest (classes 41+42); Muscadel and Cape style (classes 80-94); Standard Brandy (class 108) and Vintage/Potstill brandy (classes 109-113).

2.1 The samples of each class must be packed separately.

2.2 From 14 August 2023 the wine/brandy will be checked, labelled and collected by SAWIS officials from the cellars. Competitors may be asked by the officials to deliver large volumes of samples to SANWSA after samples are checked.

- **Copies of all WSR documents must be provided to the inspectors**
- **Minimum quantities will be strictly controlled**

2.3 All wines/brandy entered for Veritas must be stored separately from other stock. All above-mentioned stock must be stored at SAWIS registered premises or bottling organisations.

3 Double gold and gold awards – Wines for Promotion

In view of the return to normal marketing opportunities competitors who receives a double gold or gold awards are expected to supply the following quantity of the winning wines/brandies at no charge to the Veritas office for use at the different wine tastings and other marketing events through the year, viz:

Wine: 24 x 750ml or 18 litres in the case of other packaging

NLH: 12 x 375 ml or 4,5 litres in the case of other packaging

Port and muskadel: 6 x 750 ml or 4,5 litres in the case of other packaging

Museum classes: 6 x 750 ml or 4,5 litres in the case of other packaging

Brandy: 12 x 750 ml or 9 litres in the case of other packaging

Products with a cellar price of R500 or more can supply 12 bottles of wine and 6 bottles of brandy.

NB: These wines/brandies must be delivered to the Veritas office on 17 and 18 October 2023. Veritas will organise the delivery of wines to the different tasting venues.

D RULES AND REGULATIONS - WINE

1 Only one entry of a specific wine (blend) per label is allowed. When different blends of a wine are sold with a label with the same visual appearance and detail, only one entry with such a label may be made.

E BEOORDELINGSPROSEDURES

F VERITAS SEËLS

E JUDGING PROCEDURES

- 1 The Board shall, at their discretion, appoint the panel of judges to determine award recipients. The judges' ruling is final and binding on participants and no correspondence shall be entered into.
- 2 If cork taint/mouldy defects are found in more than 2 bottles per entry, said entry will be disqualified.
- 3 If deviation from any of the above-mentioned rules necessitates additional visits by the SAWIS inspectorate, the cost of these visits will be for the account of the competitor and currently amounts to ±R5.04/km for travelling expenses and R270.00/hour for the personnel involved. Both amounts include VAT and are subjected to annual adjustments and increase of fuel price.
- 4 Definition of a Dry wine: The RS of the product shall not exceed 5,0g/l, or not exceed 9,0g/l if the TA difference is below 2g/l. Refer to Table 2 – Specific requirements as prescribed in the Liquor Law.

F VERITAS EMBLEMS

- 1 VERITAS emblem (300 Double gold/ Gold) will be issued free of charge to participants who have been awarded medals according to the minimum volume entered.
 - Additional emblems may be ordered on the official order form and will be available for collection within 3 days after receipt of order.

These emblems may only be used on labels with the approval of the SANWSA, in a manner approved by the Wine & Spirit Board.

1.1 Size of the stickers with or without the judging score:
Participants can decide if they wish to order stickers with the scores (Double Gold 93 -100) and Gold (90-92), or just the Double Gold and Gold sticker without the score. Please see samples attached.

The SANWSA Council reserves the right to prohibit participation in the show if the rules and regulations are not adhered to or misrepresentation concerning awards not received or misuse of awards received, occurs.

Persons who want to mention or use Veritas awards must have the permission of the council.

Guidelines for the use of the Veritas awards:

- Only a bottle of wine carrying the appropriate Veritas award sticker may be photographed for advertising purposes.
- Therefore the Veritas award sticker may be used on its own for advertising purposes and applicants can request to receive the logos electronically and must undertake to agree to the terms and conditions.
- The Veritas logo can accompany advertising separately showing Veritas award winning wines above it or below it. The logo and the words "experience excellence" must be used together in such a case.

H MARKETING EVENTS

- 1 **VINOVERTAS by CTP APP:** GETWINE handles all the procedures to sell the Veritas award winning wines. They buy the wines directly from every participant and execute the delivery to the public. We appreciate your cooperation to deliver their order as soon as possible to enable them to get the wines to the client as quickly as possible.
- 2 It is very important that the correct TRADE PRICE of each wine is entered on the entry form. GETWINE uses that price to determine the sales price that is loaded on the APP.
- 3 If you enter an exclusive trademark that is not sold directly to the public, you should inform the Veritas office. However, we wish to encourage you to use the opportunity to sell your wines through the APP
- 4 We trust that the countrywide wine and brandy tastings will be continued this year. The details will be considered as the control over the Covid pandemic gets under way. You will be informed once a final decision has been made.
- 5 Co-operation with the Trade Veritas, in collaboration with the Trade, are planning a marketing opportunity for all Double gold and Gold winners directly following the announcement of the results. Participants are requested to supply the award winning wines to the Trade at market-related prices for this purpose. The Trade has undertaken to communicate directly with the participants regarding all purchasing arrangements.

Through these arrangement competitors have the opportunity to sell their wine, while consumers in countrywide get the opportunity to buy the winning wines. The Veritas competition is since its inception primarily aimed as a guideline for consumers to showcase the quality of the wines from South Africa.
